1. Consideration to approve purchase orders, bills, and prepaid warrant as submitted by the Director of Finance.
2. Resolution to approve 2019 Final budget transfers as presented by the Director of Finance.
3. Resolution to authorize a 2020 budget transfer from account A1990.40092 (Contingency) to account A9950.90100 (Transfer to Capital Fund) in the amount of \$19,046.
4. Resolution to authorize the transfer of \$19,045.83 from General Fund to Capital Project H0215 (Police Shooting Range and Buildings) in compliance with the original capital project budget.
