3. Resolution to advertise for bids for a 2013 Stainless Steel Sander with Hot-Dip Galvanized Cages for the Town of Webster Highway Department. – **Approved**

Resolution to abandon a Temporary Easement for the Belvedere Subdivision, identified as UE-12 and recorded in the Monroe County Clerk's Office on February 14, 1996 in Liber 8706 of Deeds at page 291 and shown on a map entitled "Belvedere Apartment Community Section One, Phase A & B, Site Plan" having drawing number 283-49, dated September 7, 1995 prepared by Charles J. Costich, P.E., L.S., P.C. – **Approved**

Resolution to approve the renewal of the Permit for Sunset Valley Trailer Park, for the calendar year 2013, that was certified by the Department of Public Works, that the Sunset Valley Manufactured Home Community Agreement is being operated according to the zoning and land use standards or requirements at the time the use was legally commenced. – **Approved**
